Public Questions/ 6. Mary Jane Burke, asked if there was anyone wishing to Comments address the Board(s). Dave Cort commented that there is a rich history of programs/services including Healthy Start, First 5 and Schoolinked Services in which the districts have worked well together. Overview and 7. Mary Jane Burke provided background information and Background an overview of the first Joint Board Meeting on September 19, 2011 in which all three Boards of Trustees elected to meet again to continue the conversation about future administrative needs. Mary Jane Burke commented that the sharing of services is already taking place in the districts. Especially in these very challenging fiscal times, we must be efficient with our resources so we can provide high quality education for our children. Discussion/Possible 8. The districts were asked to continue their Action Item(s) discussions which began on September 19, 2011 as they plan for their administrative structure in 2012-2013 and beyond. Board members were asked to review the notes from the last meeting and identify any changes with regard to the potential structure for the future; identify any new information that would be helpful to share; identify any partnerships/shared services the district is interested in exploring; and what are the next steps. The districts then came back together as a large group and reported out.

The consensus was to develop a matrix, identifying priorities, the services that each district needs and the services each district would like to share. The Marin County Office of Education was asked to facilitate this effort. Mary Jane Burke offered to meet with the Board Presidents to develop a timeline and matrix with the goal of having the Board Presidents share it with their Trustees at their April Board Meetings. Future work will also include the Nicasio, Laguna Joint, Lincoln and the Union Joint School Districts.

<u>Adjournment</u> 9. There was no motion to adjourn the meeting as there was not a guorum of the Board of Trustees.
